Supervisors discuss annex exterior options

GRUNDY CENTER — Plans for Grundy County's new annex building are quickly taking shape. Monday, AHST Architects Mardy Holst and Jacob Bauer discussed those plans with the Grundy County Board of Supervisors, including the first looks at what the building's exterior could look like.

Holst presented five renderings of possible looks, ranging from a very simple look with a slanted roof to a building with several different outcroppings and roof surfaces. Each of the renderings show a building with limestone and brick that would blend in nicely with not only the Courthouse but also the nearby Kling Memorial Library.

The simplest of the five options was quickly ruled out, with Holst noting that it might be too simple to be effective. Supervisors were split among the other options, with most preferring a look that includes a roof with a hangover as well as pillars on the north side facing the Courthouse. Supervisor Chair Mark Schildroth advised Holst to return with a proposal for the Board.

Holst also reviewed a revised floor plan for the building. The new plan provides an area with three offices as well as an exam room and waiting area for Grundy County Public Health and an area with four offices (including a manager's office), a work room, meeting room and waiting area for Grundy County Social Services. There are also shared restrooms, a shared break room and a large shared conference room suitable for about 20 people. The plan also leaves a corner of the building vacant for possible future

expansion.

Holst said, while the floor plan is fairly set, he still plans to meet with both Public Health and Social Services to make sure the buildings meet their needs.

Holst said expectations would be to put the project out for bid in time for spring construction.

Assistant County Attorney Kirby Schmidt spoke to the Supervisors about a HIPAA Policy that he is in the process of drafting for the county, as required by law, and the ramifications of the county's 'We Care' policy. 'We Care' is a voluntary program that county employees are eligible to join which sends out cards and sometimes money to employees who have suffered some sort of personal event such as surgery, hospitalization, a death in the family or retirement. The program is administered by county employees.

Schmidt said, while the intent of 'We Care' is good, it would be safer for the county to discontinue it due to its disclosure of private information.

"'We Care' is a grey area," he said. Though at least one supervisor expressed disgust with the government regulations that led to the issues, the Board directed Schmidt to write the new HIPAA Policy without the 'We Care' policy in it.

Western Home takes over Creekside project

GRUNDY CENTER — The proposed Creekside Development has new leadership.

Monday, Creekside, Inc. president John Schuller reported to the Grundy Center City Council that Creekside Inc. has transferred controlling interest of the project, which is slated to bring a variety of living options for retired citizens to a 25-acre tract of land on the city's far east side, to Cedar Falls-based Western Home Communities.

"Western Home has been our partner on this and we really got to a

point where Creekside has no financial strength to support that development," Schuller said.

Schuller said one of the organization's options was to do a major capital campaign, though with the recent capital campaign for Main Street Grundy Center and possible upcoming capital campaigns for the Grundy County Memorial Hospital and Grundy Center Preschool, they were concerned about competing for money.

"Even with a capital campaign it would have to be significant to be able to support a \$10-\$20 million project," he said. "Western Home

has the ability to step in and do a project of that magnitude, but they weren't willing to do that unless they were controlling the entity that is controlling that development."

Schuller said he anticipates that

there will still be local representation on the Creekside board and that the hospital is still working with the project.

Huckabee: Time for campaign concern a long way off

GRUNDY CENTER — Republican presidential candidate Mike Huckabee (R, Arkansas) said Tuesday that panic time for his campaign is a long way off.

During a stop in Grundy Center, Huckabee said this year's campaign is actually in a better position than it was at this time in 2008, before he won the Iowa Caucus.

"It's not unlike it's been in previous years," he said. "People are riding the crest of things at this point that don't end up being close to the top when the caucuses come around. We're where we want to be in terms of getting the organization and the structure in place."

Huckabee, who ranges from sixth to 10th in national polls and from sixth to seventh in Iowa polls, said he will not become truly worried about the polls until a couple of weeks before the Feb. 1 Iowa Caucus.

"The truth is, Iowa Caucus voters break late," he said. "Opinion polls don't mean diddly-squat at this point because they change so often. A few weeks ago, (former candidate) Scott Walker was on top of the world in Iowa."

"What we're looking at is how well we are organizing, getting to all the counties; are we building structure in each of the 99 counties in Iowa and we are," he said. "That's how we won before and that's how we need to win this time."

Huckabee spoke to a standing-room-only crowd at the Kling

Memorial Library, answering questions on issues as well as talking about his personal history, noting that he is the first man in his family to ever so much as graduate from high school.

"I've lived the American dream," he said. "To think that I would become the governor of a state and twice run for president, my gosh, that's pretty amazing to me. I know where I've come from, and it's a long way from the little red house that I lived in on Second Street."

Huckabee said he chose to run for president for a second time because he is concerned about his grandchildren's future.

"Right now, for the first time, when they are asked the question, most people don't believe that their kids and grandkids will end up living a better life than they did."

Topics of discussion during the hour-plus town hall meeting included same-sex marriage, gun control, mental health, the Trans-Pacific Partnership trade agreement, the need for a stronger military, abortion and what can be done about Russian President Vladimir Putin.

Huckabee talked briefly about his support for the Free Tax, noting that there are legislators who support it but that it needs a president to get strongly behind it to make it happen. Huckabee also noted that he was in favor of term limits for all branches of government, including judicial, and often spoke of a need for national leaders to follow the Constitution.

"As (Supreme Court Justice) John

Roberts said in his very brilliant dissent said to the same sex marriage case, 'We are on the brink of having 320 million Americans being governed by five unelected lawyers.' Our founders would be shocked if they saw what had happened to their country."

Huckabee lambasted the most recent Republican debate, noting that he only received three questions and about six minutes of time to speak during a three hour, 20 minute event.

"I wish I could take a lot of people from these town halls to have them moderate the televised debates.

I think they would be better debates. Huckabee said moderators during the Sept. 16 debate at the Reagan Library in Simi Valley, Calif. were more interested in getting candidates to attack one another than have them debate issues.

"Those of us who didn't want to play the game or spit on the other people were virtually marginalized out of it," he said.

In addition to Tuesday's stop in Grundy Center, Huckabee also held a town hall meeting in Ackley earlier in the day and had a meeting in Urbandale that evening.

Zoey Sigler: "I love going to Arlington Place because it's fun to learn about other people. I love going there to make people's day."

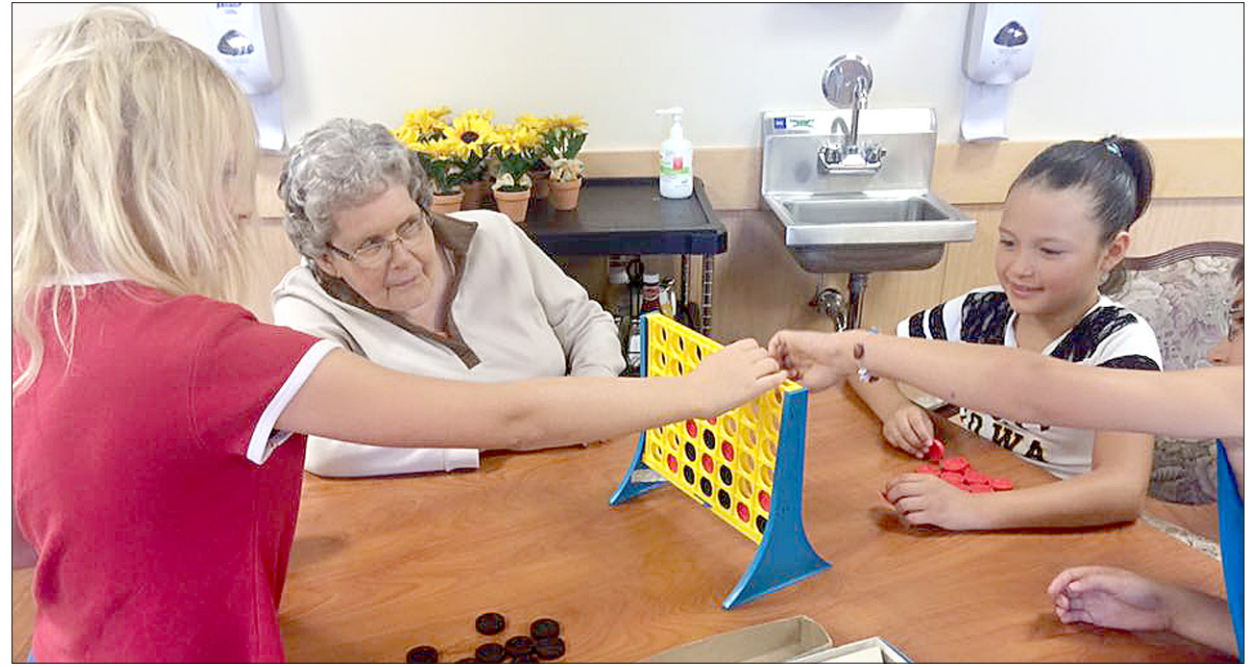
Tyler Venenga: "I think it's good to go to there to make their day. When we come we fill their day with joy. They wait for us to visit once a month. We are the highlight of their week."

Western Home has not yet announced its plans for the site, though Schuller said in conversations he has had with the group it has indicated that it expects to do a series of community meetings over the next six to nine months and hopefully break ground on the project next fall.

"Creekside is still in effect, it's just under (Western Home's) control rather than the local control," Schuller said.

Councilman Dave Steff said it seemed like the transition has gone quickly, though Schuller disagreed, saying that it has felt like the project has taken "forever" to come together.

"When we met with them a year ago and last winter, they were talking about breaking ground March 1 or April 1," he said. "April 1 has come and gone six months ago. It seems like everything (Western Home) has talked about has gone extensively beyond what they talked about. It has been a very slow process; it has been a very, at times, frustrating process, at least for us locally."

Schuller said the biggest downside to the transition is the lack of local control, though there is an upside with Western Home's financial strength.

"Ultimately we get that retirement community out there and that's what we were looking for," he said.

Steff and Councilman Al Kiewit express some concern that entities other than Western Home were not contacted about assisting with the

project. Schuller said the hospital, which is a major part of the project, preferred to work with Western Home.

IN OTHER BUSINESS, the Council approved a settlement with Andy King, owner of property in the 300 block of Seventh Street, ending a long-standing dispute between the parties.

Under the agreement approved by the Council, the City agreed to cancel the citation against King regarding the trimming of bushes and replacing the sidewalk. In return, the property owner agreed to trim the bushes off the sidewalk and repair the water shut-off valve at their cost. The City will cover 50 percent of the cost of replacing the sidewalk, up to \$1,000, which was damaged when trees were removed seven years ago.

Council also approved the first reading of an ordinance amending the powers and duties of the mayor to include serving on the Main Street Grundy Center Board of Directors. Having the mayor as part of the Board was a request from Main Street Iowa.

Council also approved the open burning period for Monday, Oct. 19 through Monday, Nov. 30 and approved trick-or-treating hours for Saturday, Oct. 31, 5:30 to 7:30 p.m.

There was also a brief discussion about extending sidewalks to the Wilhelm Sports Complex soccer fields.

The next regular Council meeting will be Monday, Oct. 19.

One rescued following single-car rollover near Dike

DIKE — A Grundy County teen was trapped and injured following a single car rollover accident in the 29,000 mile of 170th Street, about ½ mile southwest of Dike.

According to the Grundy County Sheriff's Department, 16-year-old Adrianna Murphy was travelling eastbound in a 2006 Pontiac on county gravel when she met another vehicle and lost control, entering south ditch and rolling over.

Murphy was trapped inside the vehicle and, after being rescued, was transported to Grundy County Memorial Hospital for treatment of unknown injuries.

The accident remains under investigation by the Grundy County Sheriff's Office. Agencies assisting were the Dike Ambulance and Fire Department.

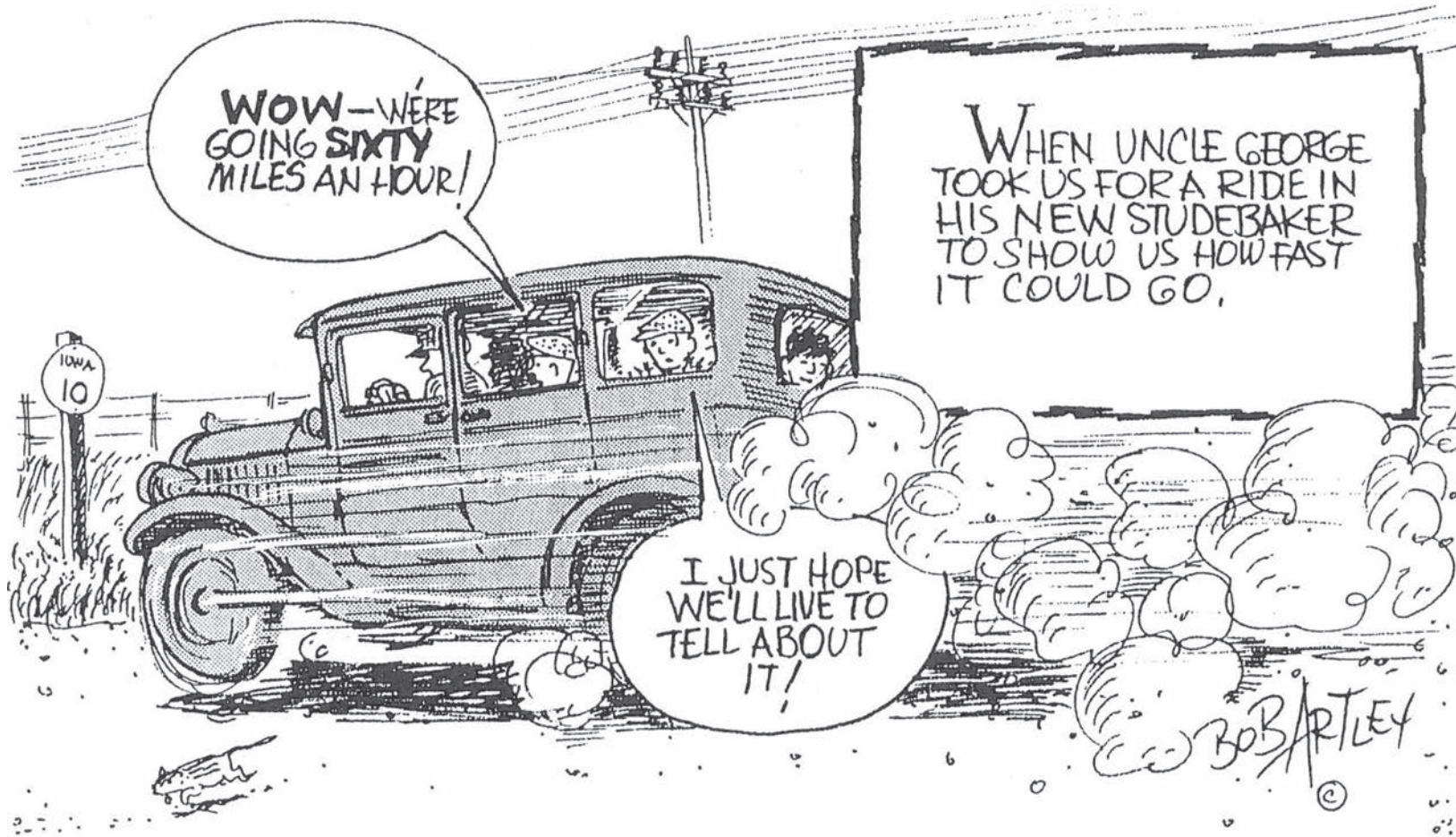

From The Cheap Seats

I've written about my fascination with bald eagles several times over the past few years. It began with a trip to Guttenberg about a decade ago and hasn't waned much since. It certainly doesn't hurt that we're in the heart of bald eagle country and that it's not all that unusual to see them here in Grundy County.

As Lynnette and I were traveling up the Mississippi River a couple of weeks ago, one thing she suggested was stopping at the National Eagle Center in Wabasha, Minn. She'd heard good things about the center (her dad likes eagles as much as I do) and thought I would enjoy it.

This is one of those times when my skepticism about tourist traps almost got the best of me. I'd been to so-called eagle centers before and had usually found one or possibly two caged birds along with some

information on their migration and maybe what had drawn them to the area. And, let's face it, most things located along or just off a highway are there for one reason ... to make money for their owners.

Lynnette wanted to stop, and a quick glance at reviews of the place online were positive, so I agreed that this might be fun. That said, I confess to having pretty low expectations. Those expectations didn't increase when we drove up to a building and they charged several dollars to get in. I feared we were paying for something we could get through in maybe 15 minutes. Boy was I wrong.

We lucked into stopping as one of the presentations about eagles was only starting. The presenter was fun, passionate and sounded like she knew what she was talking about. After maybe 10 minutes she brought in the star of the show, a 14-year-old female bald eagle named Columbia who had been brought to the center after being hit by a car. A broken wing meant Columbia could not survive in the wild, meaning that the Eagle Center would be her home. As the presenter talked, Columbia watched intently ... sometimes interacting with her handler and certainly eying the strangers who were as fascinated by her as she was of them.

The presenter had warned us of what Columbia might do if she got a little uneasy, and lucky for us she did. That meant a show of her wings and even an escape attempt. It actually made for great theater and even better photo opportunities.

The presentation itself made me feel a lot easier about the admission cost. I'd seen an eagle as closely as I ever had before, had gotten a few special pictures ... and that wasn't even the highlight. After the show, they directed us into the eagle room. There, sitting on their perches, were not just Columbia, but three other beautiful birds. All that separated the public from the birds was a, maybe, an 18-inch open barrier. Calling it a fence would be a misnomer, as we could have very simply stepped over it into the eagles' environment. There was no cage, no mesh ... just an open look at four eagles (three bald eagles and one golden eagle) who were pretty much oblivious to the public. Lynnette said I looked like a kid on Christmas morning when I saw them. I was in absolute awe!

One of the things that shocked me about the Eagle Center was its photography policy. I've been to a lot of places that won't allow flash photography or, occasionally, photography at all for fear of it distracting the wildlife. Not here. Their policy was basically "have at it." We could take all the photos we wanted, they let us use flash and we could get as close as we wanted (within reason). There was no need for special equipment ... a cell phone camera would take great pictures here.

After maybe 10 minutes in the eagle room we explored the rest of the

center. It was pretty much what you would expect. My mind, though, was on returning to the eagle room when there weren't as many people there. I had my mind on a cool picture with just Lynnette and maybe myself with the eagles. It was also fun to talk to the on-duty naturalist.

I'll still take watching eagles in the wild over seeing them in a setting like this, but I must confess that this place was way cool and someplace I'll certainly visit again if I'm ever in the area.

Closer to home, Lynnette and I spent a lot of Saturday in Grundy and Butler Counties enjoying the nice early fall weather. A lot can be said for taking a simple drive in the country at this time of year — the yellows and browns of the beans and corn make for some really fun picture opportunities.

New Hartford hosted its first-ever Pumpkin Festival Saturday, which is an event I've been looking forward to since I first saw information about it a few weeks ago. I have to commend the folks of New Hartford for putting together a great series of events that are truly germane to not only the fall season but also to our rural culture.

Northey comments on Iowa Crops and Weather report

DES MOINES - Iowa Secretary of Agriculture Bill Northey today commented on the Iowa Crops and Weather report released by the USDA National Agricultural Statistical Service. The report is released weekly from April through October.

"Iowa farmer were able to harvest a quarter of the state's 10 million acres of soybeans last week and have now 32 percent of beans out of the field. Thirteen percent of the state's corn crop has also been harvested. Both of those numbers will likely continue to grow rapidly as crops continue to dry down and even more farmers get into the field," Northey said.

The weekly report is also available on the Iowa Department of Agriculture and Land Stewardship's website at www.IowaAgriculture.gov or on USDA's site at www.nass.usda.gov/ia. The report summary follows here:

CROP REPORT

Mostly dry conditions allowed Iowa farmers to harvest one-quarter of the State's soybean crop during the week ending October 4, 2015, according to the USDA, National Agricultural Statistics Service. State-wide there were 5.7 days suitable for fieldwork. Fieldwork activities for the week included cutting hay and harvesting soybeans and corn for grain. In some areas, farmers are waiting for their crops to dry down before harvesting. There were also reports of manure being present.

Topsoil moisture levels rated 0 percent very short, 6 percent short, 86 percent adequate, and 8 percent surplus. Subsoil moisture levels rated 1 percent very short, 6 percent short, 83 percent adequate and 10 percent surplus.

Ninety percent of the corn crop was mature, 8 days ahead of last year, and 3 days ahead of the 5-year average. Thirteen percent of the corn crop for grain has been harvested, 10 days ahead of last year, but 8 days behind average. Moisture content of all corn being harvested was at 21 percent, down 3 percentage points from the previous week. Corn condition rated 80 percent good to excellent. Ninety-seven percent of soybeans were turning color or beyond, while 86 percent of soybeans were dropping leaves, 2 days ahead of normal. Thirty-two percent of the soybean crop has been harvested, one week ahead of last year, but 1 day behind average. Soybean condition rated 77 percent good to excellent.

The third cutting of alfalfa hay is 96 percent complete, 3 days ahead last year but 8 days behind the average. Pasture condition rated 65 percent good to excellent. Livestock conditions were described as excellent, with scattered reports of calves being weaned.

Fresh Pear Bread
Janice Frisbie

3 eggs	2 tsp. ground cinnamon
1-1/2 c. sugar	1 tsp. baking soda
3/4 c. veg. oil	1 tsp lemon juice
1 tsp. vanilla	1 c. chopped walnuts
3 c. flour	1 tsp salt
2 tsp. baking powder	4 c. chopped, peeled ripe pears

In a mixing bowl combine the eggs, sugar, oil and vanilla, mix well. Then combine the flour, baking powder, cinnamon, baking soda, salt and stir into the egg mixture just until moistened. Toss pears with the lemon juice and stir pears and walnuts into batter which will be thick. Spoon into two greased loaf pans, bake at 350° for 55-60 min. or until a tooth pick inserted near the center comes out clean. Cool for 10 min.

TRIPPING OTHERS

"Do not destroy the work of God for the sake of food. All food is clean, but it is wrong for a person to eat anything that causes someone else to stumble. It is better not to eat meat or drink wine or to do anything else that will cause your brother or sister to fall."
—Romans 14:20-21 NIV



Jesus gives a stern warning to anyone who might cause a believer to stumble in their faith: "If anyone causes one of these little ones--those who believe in me--to stumble, it would be better for them if a large millstone were hung around their neck and they were thrown into the sea." (Mark 9:42 NIV) If raising theological questions damages your faith, or the faith of others, then perhaps the questioning has gone too far. There is a point beyond which the intellect cannot go, though faith, hope and love may take you there. Dietary and other customs might also cause a person to stumble. Paul tells us that all things are clean to eat and drink—God does not require us to be vegetarians or teetotalers—and when you are eating as a guest to eat whatever is put before you. But if eating meat or drinking wine would cause someone in your company to stumble then we should abstain. In other words, offend no one, as far as possible. Taking a vegetarian to a steakhouse is as inconsiderate as drinking alcohol around a recently recovered alcoholic. — Christopher Simon

Willard Charles Woodring & Richard B. Buchanan

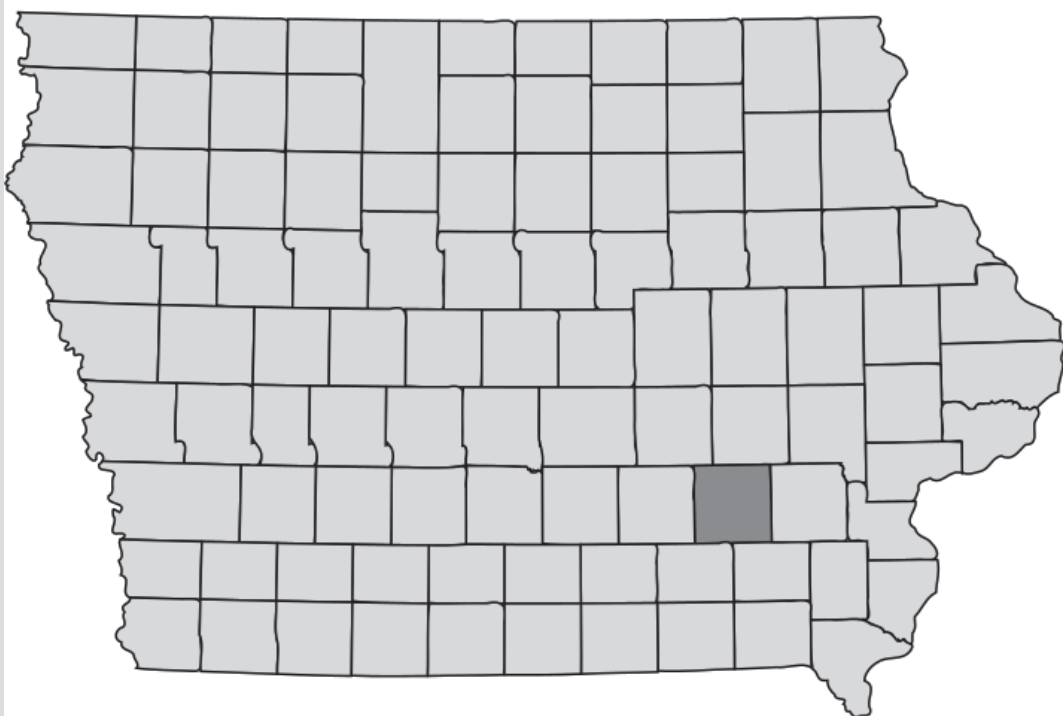
Willard Woodring and Richard Buchanan were found bound, gagged and shot to death in the kitchen of the Hawkeye Hotel, a well-known house of prostitution, in Keokuk on Sunday, Oct. 9, 1960. Police immediately launched a three-state search for a young couple who witnesses reported seeing leave the building shortly before the double slaying was reported. Witnesses described the man as about 25 years old with black hair and clad in a black leather jacket. The woman, about 22-23 years old, was described as having short red hair and wearing a lavender dress. They were thought to be driving

a car with Illinois license plates. Police believe robbery was the motive for the crime and that the killer may have been an acquaintance of Woodring. There were few signs of a struggle in the room where Woodring and Buchanan were shot and, according to investigators, the murderers "seemed to know what they were doing."

Case remains a mystery

Marshalltown woman's body found in Tama County in 1973

Halloween day, Oct. 31, 1973, was typical of many in late fall in Iowa — cold, overcast and threatening rain. But it also included the discovery of the body of Helen Mae Bown, 61, of Marshalltown, on the bank of the Iowa River northwest of Montour in Tama County. Her body was found that day by Iowa Division of Criminal Investigation agents. Bown, a widow, had been reported missing to Marshalltown Police on Oct. 7. The cause of Bown's death was listed as drowning but the circumstances never revealed.

Those on the scene of the discovery in 1973 included Tama and Marshall county sheriff's officers, Marshalltown police, agents of the then-named Iowa Bureau of Criminal Investigation, Tama County Medical Examiner Dr. C.W. Maplethorpe, as was Tama County Attorney Jared Bauch.

Bauch said recently in an email response for this article: "I remember the case and the scene. Ms. Bown had been in the water several days. As I recall there was an idea that she had been drinking quite a bit at the time she disappeared and her companions were rough customers. The DCI was on the case from the outset. I think we concluded she got in the Iowa River near Marshalltown and that it was likely a Marshall County case."

"Her appearance in Tama County was probably due to the vagaries of the Iowa River currents. We had nothing to tie her to a Tama County location at the time of her death. We did consider hers to be a suspicious death."

And it was suspicious to Marshall County authorities. Then-Marshall County Attorney Ron Kaiser convened a grand jury on Nov. 7, 1973, according to a news report in the Marshalltown Times-Republican. He told the T-R the reason for impaneling the grand jury "was to present evidence that has been uncovered."

However, no indictment was handed down and the newspaper report said Kaiser "would not comment" on whether he thought "foul play may have taken place or the nature of the evidence."

The state medical examiner had ruled the death due to "probable drowning."

Over the years no one was ever arrested nor the case of her death ever officially closed.

Recently, current Marshalltown Police Chief Mike Tupper reviewed the Bown case file which he termed "interesting to read."

"I believe it is one of those cases which could be resolved with a piece of information here and a piece of information there," he said.

Some details of the investigation are not public because the case does remain technically active, Tupper said, admitting "I asked around some of long-tenured police department employees and they were completely unfamiliar (with it)."

Tupper filled in some details not initially reported, however. Bown was reported missing by a visiting county health nurse who apparently had been caring for Bown at the time. County health nurses then and now often call upon patients who are in their own homes.

In response to rumors which reportedly circulated in Marshalltown taverns at the time, Tupper said, "From

some of the details it does look like officers did investigate multiple possibilities and did review comments people made."

He said he was uncertain why the then-termed Iowa Bureau of Criminal Investigation (now Iowa Division of Criminal Investigation) was called into the case. But he said protocol then may have been similar to today: "What we would now do."

Current Marshall County Attorney Jennifer Miller replied to an information request: "My office doesn't have any records or information on this case ... so sorry!" Helen Bown's obituary in the Nov. 7, 1973 T-R said her husband, William, had died in 1972. The couple had always lived in Marshalltown.

Tama County Sheriff Dennis Kucera and Deputy Bruce Rhoads both said they have no direct knowledge of the case as neither were serving with the sheriff's office then.

A native of Red Cloud, Neb., Bown had married her second husband, William, in 1964. She had previously married Orville Berger in 1926 when she was 14 years old. They had two sons.

Bown was buried in Riverside Cemetery in Marshalltown. The website - iowacoldcases.org - includes this information about the case:

In a Des Moines Register article dated Nov. 2, 1973, one official not directly connected with the case said the manner in which the investigation was being handled would lead one to believe "the Watergate tapes or the atomic bomb secrets" were involved.

Additionally, the paper also reported that "no one in an official capacity would say why the search for the woman was concentrated in the area northeast of Le Grand."

The Bown case was the second time in which a Marshalltown woman's body would be discovered in Tama County. Earlier that year, the body of Rochelle Lass, Marshalltown, was found on a rural Tama County road north of Montour on Feb. 22, 1973.

That case was solved with the arrest and subsequent conviction of her husband, Dennis Lass, for first-degree



murder. Lass, who had been employed as an insurance adjuster, died in prison in April of 2014 at age 73, while serving a life term.

The couple had lived in Toledo for a period of time before moving to Marshalltown.

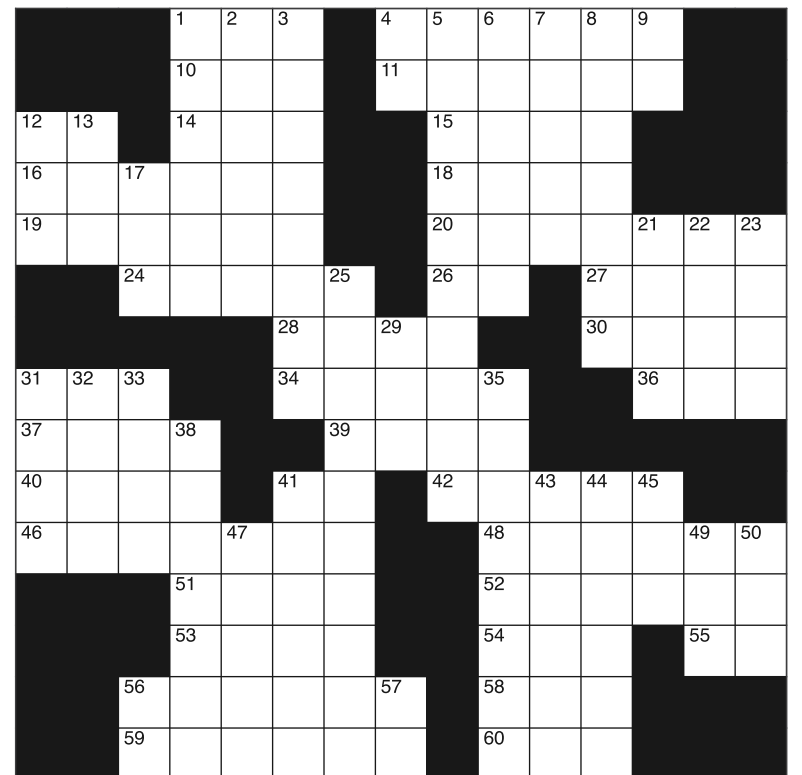

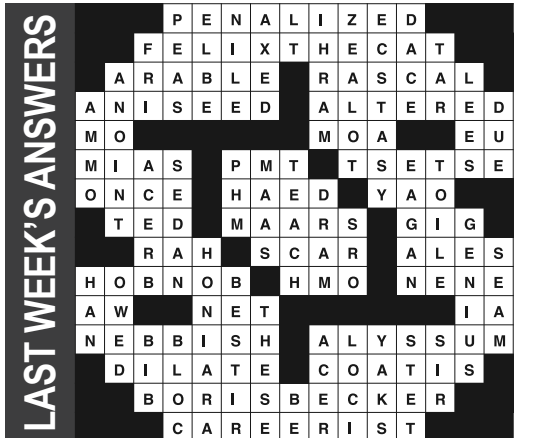

Flater's big night leads Spartans past Comets

CONRAD — Grundy Center tailback Bryce Flater ran wild on Friday night, racking up 319 yards and five touchdowns on just 15 carries in a 54-7 Spartan victory over BCLUW in Conrad.

"Bryce did a lot of work on his own, but the offensive line did a great job up front," Grundy Center Coach Brent Thoren said. "Bryce runs hard. He's tough to bring down, but to get him a head of steam for five yards before first contact ... it's tough to get him down in those situations."

The Comets nearly scored early after Grundy Center's Austin Burroughs muffed a punt that was recovered by Caleb Engle. Quarterback Brad Barkema found a streaking Clay Silver on a pass down to the five-yard line, and the Comets were knocking on the door. On the next play, however, Burroughs got his revenge with an interception in the end zone, and the Spartans opened their drive at their own nine-yard line.

"I hate harping on how young we are, but until we learn the lessons that we're being taught, we're going to keep being a young team," BCLUW coach Anthony Jahr said. "When you've got the ball on the five yard line, you can't throw into triple coverage."

Flater proceed to break his first big run of the night, a 41-yarder, to move his team into the red zone. Though they relied on their ground game for most of the night, the Spartans scored their first touchdown through the air when Burroughs found receiver Jared Krausman on a crossing route for a 22-yard score - just Burroughs's second passing touchdown of the year (both to Krausman) with 4 minutes, 58 seconds remaining in the opening frame.

On the ensuing Comet drive, Grundy Center defensive back Jack Stumberg intercepted Barkema at the 35-yard line and returned it all the way down to the eight-yard line. On the next play, Flater punched in the first of his five touchdowns on the night from eight yards out, and the Spartans took control with a 14-0 lead late in the first quarter.

Barkema threw his third pick of

the night on the next drive, this time to Chase Boren, which was returned down to the Comet six-yard line. The Comets got to Burroughs, twice, however, and pushed the Spartans back to the 20-yard line before Stumberg missed a 37-yard field goal attempt.

After another Comet drive stalled at their own 42, the Spartans reclaimed possession, and four plays later Flater broke off a 51-yard touchdown run on a toss to the right. BCLUW went three-and-out on its next drive, and Flater went 52 yards for his third score to make the score 26-0 with 4:35 to play in the first half.

Flater scored from 51 yards out with 1:04 remaining in the half and added a two-point conversion to make the score 34-0 heading into the locker room, and he punched in yet another touchdown, this one from 32 yards, in the middle of the third quarter. Burroughs connected with Stumberg on a 38-yard seam route, and Tim Knock ran in from 15 yards to push the score to 54-0.

Barkema found Silver in the back of the end zone on the lone touchdown of the night for the Comets in the fourth quarter, but the Spartans controlled the contest throughout. Flater averaged 21.3 yards per carry and Austin Knaack added seven carries for 83 yards in his first extensive varsity action for the Spartans, who totaled over 400 yards of offense.

Burroughs completed four of his five passing attempts for 78 yards and two touchdowns. Knock led the defense with 7.5 total tackles and a solo sack.

"(Flater) is a great back," Jahr said. "He's so smart. He knows how to do everything well and set his blocks up."

BCLUW's offense was anemic. The Comets totaled just six rushing yards and 121 yards of total offense. Barkema finished 12-of-26 with 115 yards, a touchdown and three interceptions. Silver caught five passes for 68 yards and a score and led the defense with 10 total tackles (all solo).

"If we don't do the little things, we're not going to be able to just show up and beat people. We have to do a lot of things well to beat people, and we can't get away with some of the things that these bigger, stronger teams can," Jahr said.

With the win, Grundy Center improved to 4-2 overall and 3-0 in district play, and the Comets fell to 2-4 overall and 1-3 in the district.

Up Next

The Spartans travel to district-leading Denver Friday before hosting defending state runner-up Gladbrook-Reinbeck on October 16 while BCLUW makes the long trip to Wapsie Valley in rural Fairbank.

"If we want to be spoken about in the same sentence as those guys (G-R and Denver), we've got to prove it on the field the next two weeks," Thoren said.

Wolverines overcome sluggish first half, score first shutout

DIKE — Dike-New Hartford overcame three first-half turnovers in the red zone on its way to a 42-0 victory over MFL/MarMac Friday.

The Wolverines (6-0 overall, 3-0 in Class 1A, District 4) won despite coughing the ball up on four straight possessions in the second and third quarters. They were aided by four MFL/MarMac turnovers and a defense that held the Bulldogs out of the end zone despite allowing more than 200 yards of offense.

Wolverine coach Don Betts admitted that Friday's game was one that he had some concerns about.

"You can't get them all wound up for the Super Bowl every single week, it doesn't work that way," he said. "We've got another big one coming up next week, this was one that we just needed to take care of business, and eventually we got around to it. It just took us a little longer to get going than we would have liked."

D-NH finished with 358 yards of offense, a total that could have been much more if not for the turnovers. The Wolverines never punted the ball and averaged 7.2 yards per snap. Trent Johnson led the way with 182 rushing yards and a pair of scores while Connor Neuroth finished with 90 yards rushing and 43 receiving in addition to returning a kickoff for a touchdown. Quarter-

back Jacob Moore threw the ball just eight times, completing three for 56 yards.

The Wolverine defense bent but didn't break. MFL/MarMac penetrated D-NH territory five times, only to be slowed. Bulldog fullback Tanner Kregel, seeing his first extensive carries of the season, gained 29 of his 43 yards in the first half while halfback Colby Ferguson hit a couple of big gains in the second half and finished with a team-high 45 yards. MFL quarterback Tristen Kaufman hit just 4 of his 19 pass attempts for 62 yards with three interceptions.

"They did a nice job," Betts said of the Bulldogs. "They came in and played to their strengths. They've always seemed to have a nice fullback up there, they played hard and were able to get some plays on us. They really didn't do anything we didn't expect, we just weren't able to execute as well as we should have."

The Wolverines took control of the game in the first nine minutes. Neuroth capped their first drive with an 18-yard scoring run from the Wildcat formation while Johnson powered into the end zone on D-NH's second possession. A bad snap on the PAT kick attempt after the first touchdown prompted Moore threw to Nic Gronowski for the two-point conversion and Jackson Lage suffered a rare missed extra-point kick following the sec-

ond score, leaving the score 14-0.

Two Wolverine fumbles and an interception, all inside the MFL/MarMac 20, kept D-NH from building its lead and it went to the locker room with the game still squarely in the balance, 14-0.

"We just told them (at half-time) that we're a better football team than we played in the first half," Betts said. "There wasn't any screaming or yelling or anything like that, we just told them they were a better football team and they knew they were. We made a ton of mistakes and needed to clean that up in the second half and come out and show them the kind of team that we really are."

Neuroth returned the second-half kickoff 82 yards for a touchdown, giving the Wolverines a little more breathing room.

"He's not only a playmaker, but he's also a kid that when you need a spark he's there to make it," Betts said of Neuroth. "Those kids are special. He's a special player."

Johnson's second scoring run of the night, a 23-yard scamper, but the game out of reach. D-NH added a pair of fourth-quarter touchdowns to account for the final scoring.

Up next

The Wolverines play a key game on the road Friday against South Winneshiek. The winner of that game will have the inside track to the District 4 championship. MFL/MarMac will look for its first Dis-

trict 4 victory at Clayton Ridge.

GRUNDY CENTER — The Grundy Center High School volleyball team made a statement to Class 2A Saturday that it will be a major player in the postseason.

The Spartans scored four victories over top-six ranked opponents, all from larger classes, on their way to the Waverly-Shell Rock Tournament championship.

Spartan coach Lori Willis said her team did a lot of things right while winning its first tournament title since 2012. The title was Grundy Center's first ever in the Waverly-Shell Rock tourney.

"Everyone on the team contributed this weekend at Waverly which was the driving force to the success we saw over the over highly ranked teams," she said. "The girls played well as a team. They communicated more than they have in the past but they still have so much room to grow in this area yet."

"They also played extremely aggressive," she said. "We were hitting the ball hard and when we did tip they were smart tips. Passing was better than it has been and that is a focus of ours. We made smart choices with our sets and were able to improve on some new things that we have been working on as well."

The Spartans (22-7 and ranked No. 8 in Class 2A) went 4-0 in pool play, downing unranked Mason City 21-4, 21-16, Class 3A No. 3 ranked Nevada 19-21, 21-18, 15-11, unranked Gladbrook-Reinbeck 21-7, 21-13 and Class 3A No. 5 Mount Vernon 21-17, 21-12.

Willis said her team took things away from Nevada in the final two sets that it was able to do well in the first set. "Game three we jumped out to a lead and then they would slowly catch up and until we built another lead and which they would catch up yet again," she said.

The deciding game was tied 13-13 when the Spartans picked up a kill to take the lead and then won it with an ace serve.

GC swept Class 4A No. 6 Waverly-Shell Rock 25-17, 25-15 in the semifinals and had a rematch with Nevada in the final, winning 14-25, 25-13, 15-13.

"At the end of the day I was so proud of the girls for the heart they showed and the ability to love up on each other during hard times that it brought me to tears," Willis said. "This is a great group of girls and I am honored to be a part of their lives."

Grundy Center had a balanced offensive attack during the tournament, with no fewer than five girls recording more than 20 kills. Katie Lindeman led the way with 30 kills while Hanna Edgerton recorded 26, Kylie Willis 23, Alyssa Mathews 22 and Landry Lühring 21. Mathews also had 104 assists during the tournament while Piper Johanns recorded 59 digs and both Johanns and Kayla Mathews had five ace serves each.

"The girls keep getting better and better each week," Willis said. "Every time we play we do something better or something we have never done before. I believe most of that comes from team chemistry and getting used to the rolls each player has this year. You can never underestimate the power of becoming one as a team. Every time this team steps onto the floor they are getting better and better at it."

Willis added that she believes the tournament success can lead to bigger things in coming weeks.

"We have been in a lot of close matches with a lot of great teams but have been on the wrong side of the deciding match by only 2-3 points," she said. "The girls knew that it was only a matter of time when those games were going to start to go our way if they kept working hard and believing in each other. They did just that this past weekend by beating Nevada twice. Nevada is a good team with a great coach. Those were big wins for us. Our focus is to keep getting better, to keep learning, and keep

pressing on. When we do those things we can face any team with confidence even during regional play."

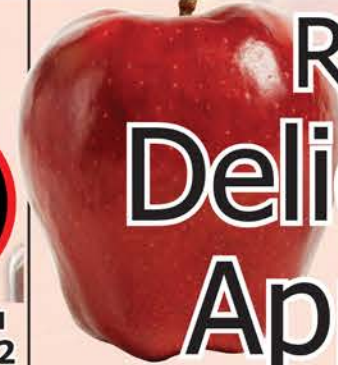
